## REPLY TO YOUR SHOW CAUSE NOTICE DATED 14.10.2018

Sir,

This is in response to your show cause notice dated 14.10.2018 whereby you have asked to respond why the legal action should not be initiated against the undersigned for publishing a circular dated 01.10.2018, which has defamed you. It is submitted that the circular issued has been wrongly construed by you as the undersigned has never used defamatory words against you, and the words were used against the alleged members who have been blackmailing and pressurizing the Society, which you have stated in your article against the Society which was in fact defamatory, and you published the same without even waiting for the response, as the questions in your email was itself vague and requires consideration and also to verify your background and genuineness.



Similarly the show cause notice issued by you under reply you have given two days 2 days time, as in earlier email you have given 1 day time, it is submitted that the Managing Committee members are honorary posts and requires due consideration of all Managing Committee member and legal advice before giving any reply but you did not gave any time, as it appears you are bent upon to label the Society as fraud without even verifying the facts. It is submitted that articles you have based on the contents allegedly provided by one Sh. Moti Lal Meena, Sh. Deepak Khanna, Sh. Umesh Vig and Sh. Sudhir Kalra and their letter has been published in your defamatory articles without verifying the facts and contents and even verifying the background of these persons.

That it is pertinent to write that Sh. Deepak Khanna, is a expelled member of the Society, who has deposited only Rs. 100/- in the Society and did not pay a single penny neither for land cost nor for construction, as Mr. Deepak Khanna is having no force at all on the legal issues to restore his membership, due to this reason he has not filed any case as per the Delhi Cooperative Societies Act and Rules against the Society but you the above addressees has made Sh. Deepak Khanna as a Hero of your articles and published his contents without verifying the same.

That it is further pertinent to write that you the above addressees have published the letter of Sh. Sudhir Kalra, who is alleged himself as a member of the Society, however, he is an accused in FIR No.0118/2016, lodged at P.S.Sector-23, Dwarka, under section 420 IPC and was a proclaimed offender who has been recently arrested by the Delhi Police. It is further worthy to inform you that Sh. Sudhir Kalra is facing the criminal trial under section 499/500 IPC before the Learned Metropolitan Magistrate, Rohini Courts, Delhi. Mr.



Sudhir Kalra is claiming the membership of 117 members of the Society, who allegedly holds the membership prior to 1997, but till date not a single member has filed any arbitration case against the Society for restoration the their membership. Being the Editor of the newspaper, you the above addressees must be aware of the catena of judgment passed by the Hon'ble High Court of Delhi as well as the Hon'ble Supreme Court of India in which it was held that the member who has not contributed in the land cost and the construction cost have no right to take flat in the Society in advance stage. Mr. Sudhir Kalra with the sole motive to extort the money from the Society claiming the rights of 117 members in the Society and just to avoid any litigation with the approval of the General Body, some of the alleged persons has been paid money, but now said Sh. Sudhir Kalra is bent upon to blackmail the Society in the shield of the alleged members who appears to be not existent.

That it is further pertinent to write that you the above addressees have published the letter of Sh. Umesh Vig, Ex President of the Society. It is worthy to mention that Sh. Umesh Vig has played the fraud with the Society by executing the false affidavit that he is not holding any property in Delhi, however, he was having his property in Kingsway Camp, prior to becoming the member of the Society. It is further worthy to mention that Mr. Umesh Vig has also managed to get the membership of his dependent sons Gaurav Vig and Saurav Vig in the Society. After getting the knowledge of the same, the Society filed the disqualification case against Sh. Umesh Vig, and his sons, as all the three were the defaulters, the Society was forced to expel them from the primary membership of the Society and now their case is pending before the Hon'ble Court of Registrar Cooperative Societies as well as Delhi Cooperative Tribunal.

That from the above it is crystal clear that the allegations leveled by you against the Society on basis of the contents provided by the above so called members, is not right, even otherwise if you think that the undersigned has defamed you by the circular, then the undersigned tenders the unconditional apology, and hope that you should also realize your mistake and publish the unconditional apology in the newspaper regarding publishing defamatory and untrue article against the Society.
